1. The BOD's supervision of the BOM:

- Implementing sustainable development strategy following the model of "Circular Agriculture" by application of scientific advances and technological solutions to recycling by-products and waste from the crop and livestock farming process to, in return, serve the agricultural production process, forming a supply fatherin, closed loop production. The goal is to create safe, high-quality products, reduce resource waste and environmental pollution approaching sustainable development;
- Completing the private placement of shares to supplement working capital for subsidiaries, settling the Company loans and its subsidiaries in accordance with the capital use purposes approved by the General Meeting of Shareholders;;
- Successfully holding the 2024 General Meeting of Shareholders;
- Regularly auditing the BOM administration and operation to require implementation of the best governance practices to ensure the rights and interests of shareholders, customers and employees in the Company;
- Supervising and steering the disclosure of information ensuring transparency, completeness and promptness in as required by law.

Based on the tasks that have been implemented, the BOD assessed that the BOM had closely observed and complied with the direction given by the BOD; meanwhile the BOM fully complied with the functions and duties as specified in the Company Fatherrter.
